### UTILITY DISCOUNTS SNOHOMISH COUNTY

The information listed below is ***general*** information only. Some discount programs allow for certain deductions before applying the income guidelines. If you have any questions regarding eligibility and/or income guidelines for a program below, please call the number listed. If a utility company is not listed here you may want to contact that particular company and ask if they offer a utility discount.

#### **HEATING**

##### **Snohomish County Public Utility District (PUD)**

**425-783-1000, 1-877-783-1000** (press option #2 - both numbers).

Can apply for the discount at any time during the year. Seniors receiving the Senior Discount must reapply **ONLY** if their income has changed from the previous year.

- Senior Income Guidelines: 62+, with a household income \$24,563/year. May deduct the costs of Medicare Premiums, in-home and nursing home care costs and prescriptions.
- Call PUD for low-income, discount guidelines for persons under 62 years of age.

##### **Energy Assistance Program - Snohomish County**

**425-388-3880**

One-time annual heating assistance (Low Income Home Energy Assistance Program / LIHEAP). All sources of heat are considered.

- Low Income Home Energy Assistance Program / LIHEAP Income guidelines: Income Guidelines: 1 person \$1,046.00/month and 2 persons \$1,426.00/month.
- **Puget Sound Energy Assistance Program / PSE Income guidelines:** Income Guidelines: 1 person \$1,300.00/month and 2 persons \$1,700.00/month.

##### **Project Pride – American Red Cross**

**425-740-2333**

Provides assistance with Snohomish County Public Utility District (PUD) electric bills. Applicants must apply for Snohomish County Energy Assistance Program funds. If the Energy Assistance Program assists a person they can not be considered for Project Pride. Applicants must have a "past due" or "disconnect" notice. The PUD bill must be in the name of the person applying for assistance.

1 person \$1,170/month, 2 persons \$1,568/month

## WATER - SEWER - GARBAGE – RECYCLE

### Alderwood Water District

Water/sewer discount.

- Age Guidelines: 62+
- Income Guidelines: household income \$18,000/year.
- Applicant must be the resident and named on the billing statement .
- Renters with individual water meter are eligible for water discount.

### City of Arlington

360-403-3421

Water/sewer discount.

- Age Guidelines: 61+
- Income Guidelines: household income \$28,000/year.
- Applicant must be the resident and named on the billing statement.
- Renters with individual water meter are eligible for water discount.

### City of Edmonds

425-771-0241

Water/sewer discount.

- Age Guidelines: 18+
- Income Guidelines: household income \$25,000/year for 50% disc, \$30,000/yr for 30% disc.
- Applicant must reside at the address, can be homeowner or renter.

### City of Everett

Water/sewer discount.

- Age Guidelines: 62+ or disabled (must qualify for disabled parking in order to be eligible).
- Income Guidelines: household income \$35,000/year.
- Applicant must live in single family home and be receiving the Snohomish County Property Tax exemption.

### City of Gold Bar

Water/Recycling discount.

- Age Guidelines: 62+ (or age 55+ and disabled)
- Income Guidelines: 1 person \$19,300/year and 2 persons \$22,030/year.

### City of Granite Falls

Water discount.

- Age Guidelines: 62+, disabled, low-income.
- Applicant must be the homeowner and be receiving the Snohomish County Property Tax exemption/reduction.

### City of Lake Stevens

Garbage discount.

- Age Guidelines: 62+ or disabled.
- Income Guidelines: 1 person \$27,250/year and 2 persons \$31,150/year.

### City of Marysville

Garbage/sewer/water discount.

- Age Guidelines: 62+ or disabled.
- Income Guidelines: 62 + household income \$25,000/year. Call for income guidelines for persons under 62 with disabilities.

## WATER – SEWER – GARBAGE – RECYCLE

### City of Marysville 360-363-8000

#### Utility Tax Rebate

- Age Guidelines: 62+ or disabled.
- Income Guidelines: household income \$25,000/year.
- City of Marysville tax rebate on PUD, telephone and PSE bills.

### City of Monroe 360-794-7400

#### Water/garbage/sewer/recycling discount.

- Age Guidelines: 62+ or disabled.
- Income Guidelines: 1 person \$27,250/year and 2 persons \$31,150/year.
- Applicant must be primary occupant of household & provide proof of income and birth date.

### City of Mountlake Terrace 425-744-6214

#### Solid Waste/water/sewer

- Age Guidelines: any age for waste discount, must 62+ for water/sewer discount.
- Income Guidelines: 1 person \$13,720/year and 2 persons \$18,470.99/year.

### City of Mukilteo 425-355-4141

#### Storm drain discount.

- Age Guidelines: 18+, low income or disabled.
- Income Guidelines: currently receiving Snohomish County Property Tax exemption.
- Must be owner of single-family residence.

### Silver Lake Water District 425-337-3647

#### Water/sewer discount.

- Age Guidelines: 62+
- Income Guidelines: 1 person \$14,000/year and 2 persons \$18,000/year, or receiving Snohomish County Property Tax exemption/reduction.
- Discount for owner or renter.

### City of Snohomish 360-568-3115

#### Water/sewer/garbage discount.

- Age Guidelines: 62+, or disabled **and** low-income.
- Income Guidelines: 1 person \$27,265/year and 2 persons \$31,160/year.

### City of Stanwood 360-629-9617

#### Water/sewer discount.

- Age Guidelines: 62+ or disabled.
- Income Guidelines: 1 person \$21,800/year and 2 persons \$24,925/year.
- Discount for owner or renter.

### City of Sultan 360-793-2231

#### Water/garbage/sewer discount.

- Age Guidelines: 62+
- Income Guidelines: 1 person \$12,768/year and 2 persons \$17,112/year.
- Applicant must reside in the home and have utility account in her/his name.

## WATER - SEWER - GARBAGE – RECYCLE

### Snoh. Co. Solid Waste Management Senior Discount Program 425-388-3425

Discount for transfer stations only - does not apply to curb side garbage pickup.

- Applicant must be 60+ years of age, a permanent resident of Snohomish County and meet the low-income guidelines (disabled senior applicants are allowed a slightly higher income level).
- Gross household income guidelines: 60+ 1 person \$14,700 and 2 persons \$19,800  
60+ **and** disabled: 1 person \$19,600 and 2 persons \$26,400.
- Fees are \$2.00 per visit, up to 4 (cans, bags, boxes) per visit, limit of 20 visits per year.
- All garbage must be in some type of container (cans, bags, boxes etc).

## TELEPHONE/CABLE

### Comcast Cable Services 1-877-824-2288

Discount on basic cable and installation. Age Guidelines:

- 65+ or disabled (in some areas age eligibility is 62+).
- Income Guidelines: household income \$17,500/year.
- Discounts vary depending on service area.

### Washington Telephone Assistance Program - Verizon Service 1-800-483-4100 - WTAP Information 1-888-700-8880

This program is available for people who are on a Washington State assistance program, such as Food Assistance, Medicaid Medical, or COPES and meet eligibility criteria. Program provides a monthly phone discount and a discount on connection fees.

- Applicants must be below 135% poverty level.
- Applicants must participate in public assistant program.
