UTILITY DISCOUNTS SNOHOMISH COUNTY

The information listed below is ***general*** information only. Some discount programs allow for certain deductions before applying the income guidelines. If you have any questions regarding eligibility and/or income guidelines for a program below, please call the number listed. If a utility company is not listed here you may want to contact that particular company and ask if they offer a utility discount.

Alderwood Water District Water and Sewer Discount	(425) 743-4605	Water and sewer discount.	62+ with household income of \$30,000 a year or less will receive 34% discount. Applicant must be the resident and named on the billing statement. Renters with individual water meter are eligible for water discount.

American Red Cross (Snohomish County) Project Pride	(425) 740-2333	Provides assistance with PUD electric bills. Applicants must apply for Snohomish County Energy Assistance funds when available. If a person has been assisted by the energy assistance program they will NOT be eligible for Project Pride ass	Anyone who has received a disconnect notice and had no help from Energy Assistance in the past annual heating season. Maximum Monthly Income guidelines: One person: \$1241, Two persons: \$1670. Income is counted for all household members 18 and older.
AT&T AT&T Lifeline	1-800-377-9450	The program, funded by the federal government, makes it possible for low-income residents to get a free phone and a low-cost monthly service plan.	Household income must be at or below 135 % of the Federal Poverty Guidelines, or you must be participating in any of these programs: Medicaid, Food Stamps, Supplemental Security Income (SSI), Federal Public Housing Assistance (Section 8), Low-Income Home Energy Assistance (LIHEAP), National School Lunch Program's Free Lunch Program, Temporary Assistance for Needy Families (TANF). If you live on tribal lands, you could also qualify for Enhanced Lifeline support if you meet the above requirements or participate in any of the following programs: Bureau of Indian Affairs (BIA) general assistance, Tribally Administered Temporary Assistance for Needy Families (Tribal TANF), National School Program's Free Lunch Program, Head Start (meeting income qualifying standards).
City of Arlington Water and Sewer Discount	(360) 403-3421	Water and sewer discount.	You must be 61 years old or older. Total household income must be \$28,000 or less including all interest income, pension, and Social Security earned. Applicant must be the resident and named on the billing statement. Renters with individual water meter are eligible for water discount.

City of Edmonds Water and Sewer Discount	(425) 771-0241	Water and sewer discount.	18+. Income guidelines: households of \$25,000 per year or less receive a 50% discount; households of \$30,000 per year or less receive a 30% discount. Applicant must reside at the address, can be homeowner or renter.
City of Everett Water and Sewer Discount	(425) 257-8999	Water and sewer discount.	62+ or disabled. Senior Discount based on yearly income: \$25,000 or less per year: 40% discount, \$25,001 - \$30,000 per year: 30% discount, \$30,001 - \$35,000 per year: 20% discount. Disabled: Must qualify for a disabled parking permit. Income guidelines: \$35,000 or less pre household. Only applicant and spouse may have income within the household. Must be receiving property tax exemption.
City of Gold Bar Water and Recycling Discount	(360) 793-1101	Water and recycling discount.	62+ or age 52 and disabled. Income Guidelines: 1 person - \$19,300/year, 2 persons - \$22,050. Applicant must be resident and named on the billing statement.
City of Granite Falls Water Discount	(360) 691-6441	Water Discount.	Seniors 62+, and disabled. Applicant must be the homeowner and be receiving the Snohomish County Property Tax exemption/reduction.
City of Lake Stevens Garbage Discount	(425) 334-1012	Garbage discount.	62+, or disabled. Income Guidelines: 1 person \$29,500 gross per year, 2 persons \$33,700 gross per year, 3 persons \$37,950 gross per year. Income guidelines for households with 3+ people call the City of Lake Stevens.

City of Lynnwood Water and Sewer Discount	(425) 760-5000	Water and sewer discount.	61+, customer of Lynnwood Utilities, owner of single family residence for which a property tax exemption has been granted.
City of Marysville Garbage/Sewer/Water Discount	(360) 363-8001	Garbage, water and sewer discount.	Age: 62+ or disabled. Income guidelines for 62+: household income \$25,000 per year. Call for income guidelines for persons under 62 with disabilities.
City of Marysville Utility Tax Rebate	(360) 363-8001	Utility tax rebate on PUD, telephone and PSE bills.	Age 62+ or disabled. Annual household income of \$25,000 per year or less. Disabled must have proof of disability.
City of Monroe Community Utilities Program-CUP Fund	(360) 794-7400	Assists persons in paying their water, sewer, garbage, and recycling bills, if they are in danger of losing services and funds are available. Maximum grant is \$25 per year, as funds are available.	Any resident of Monroe in danger of losing utility services
City of Monroe Utility Discounts	(360) 794-7400	Water, garbage, sewer and recycling discount.	62+, or disabled. Income guidelines: 1 person \$29,500 per year: 2 persons \$33,700 per year. For households with 3+ people call the City of Monroe for eligibility guidelines. Applicant must be primary occupant of household and provide proof of income and birthdate.

Annual Income guidelines: 1 person, \$15,161, 2 people, \$20,398, 3 people, \$25,634. City of Mountlake Terrace Water and Sewer Discounts	(425) 744-6214	Water, and sewer discount.	Annual Income guidelines: 1 person, \$15,161, 2 people, \$20,398, 3 people, \$25,634. Check website at www.cityofmlt.com or call the City of Mountlake Terrace for more information and guidelines for larger families.
City of Mukilteo Storm Drain Discount	(425) 263-8035	Storm drain discount.	18+, disabled or low-income persons who are currently receiving the Snohomish County property tax exemption (household income less than \$35,00 per year). Applicant must own a single-family residence.
City of Snohomish Water, Sewer, Garbage Discount	(360) 568-3115	Water, sewer, garbage discount.	Low-income 62+ or low-income disabled . Income guidelines: 1 person, \$29,500 per year: 2 persons, \$33,700 per year. Call for income guidelines for over 3 people living in the household.
City of Stanwood Water and Sewer Discount	(360) 629-9617	Water and sewer discount.	62+ or disabled and low-income. Income guidelines: 1 person \$22,800 per year: 2 persons \$26,025 per year or less. For households with 3+ people call the City of Stanwood for eligibility guidelines. Discount for owner or renter.

City of Sultan Utility Discounts	(360) 793-2231	Water, garbage, sewer discount.	Age: 62+ and low-income . Applicant must reside in home and have utility account in his/her name. Can deduct yearly property taxes from gross income to meet income guidelines. Income Guidelines: 1 person: \$12,768 per year, 2 persons: \$17,112 per year.
Comcast Senior and Disabled Discount	(800) 266-2278	Offers a 30% discount on limited cable services. Brier residents also receive free installation.	65+ or permanently disabled. Income guidelines: \$17,500 per year or less per household.
DSHS - Community Services Division Washington Telephone Assistance Program (WTAP)	1-888-700-8880	Program provides a monthly phone discount and a discount on connection fees. When contacting Verison you must have your DSHS client ID number.	This program is available for people who are on a Washington State assistance program, such as Food Assistance, Medicaid Medical, or COPES and meet eligibility criteria.
Silver Lake Water and Sewer District Water And Sewer Discount	(425) 337-3647	Water and sewer discount.	62+ homeowners who are currently receiving Snohomish County property tax exemption will qualify for discount. Renters Income Guidelines: 1 person, \$35,000 per year: 2 persons, \$40,000 per year.
Snohomish County Human Services Department Low Income Home Energy Assistance Program (LIHEAP)	(425) 388-3880	One-time annual heating assistance. All sources of heat are considered.	LIHEAP Income guidelines: One person: \$1,128 per month, Two persons: \$1,518 per month.

<p>Snohomish County Human Services Department</p> <p>Puget Sound Energy Assistance</p>	(425) 388-3880	Offers assistance for customers of Puget Sound Energy (PSE) with gas bills, including heating or any gas appliance. Assistance is subject to availability of funds.	Any Puget Sound Energy (PSE) customer, home owners or renters. Must have name on account to apply for help. Net income guidelines: 1 person - \$1,354 per month, 2 persons - \$1,821 per month.
<p>Snohomish County Human Services Department</p> <p>Washington Energy Assistance Fund (WEAF)</p>	(425) 388-7200	Offers assistance for customers of Cascade Natural Gas with heating costs. This is a year around program, customers do not need a "disconnect notice" to apply. Assistance is subject to availability of funds.	Income guidelines - One person: \$1,128 per month, two persons: \$1,518 per month.
<p>Snohomish County Public Utility District #1</p> <p>Senior And Low Income Discounts</p>	(425) 783-1000 or 1-877-783-1000	Can apply at any time during the year. Seniors 62+ who are currently receiving a PUD discount must submit a renewal application ONLY if the household income has changed.	For Senior Discount age 62+: must not be receiving any other PUD discount. Total household income must be at or below \$25,988 per year. Persons applying for the Senior Discount may deduct their Medicare Part-B premium, Part-D premium, prescriptions (on a case by case basis), as well as in-home care and nursing home expenses in order to meet income guidelines. For Low-income Discount: household income must be below 125% of the federal poverty level. Call PUD for eligibility guidelines.
<p>Snohomish County Solid Waste Management Division</p> <p>Senior and Low Income Discount Program</p>	(425) 388-3425	Offers disposal discount card for garbage disposal at transfer stations. Discount does NOT apply to curb side pick up. Discount applies to transfer station only. All garbage must be contained in bags, cans, boxes etc.	Seniors 60+ or disabled person, resident of Snohomish County, and meet income guidelines: 1 person - \$16,200 2 person - \$21,800 Disabled 1 person - \$21,600 Disabled 2 person - \$29,100
